Coronavirus (COVID-19) pandemic

17 July 2020

Purpose

This briefing is to update all on the ongoing development and management of the COVID-19 pandemic, including the current situation in the UK, and some key wider public health responses, mainly from a national level.

Latest on Coronavirus

- Risk Level – 3
- UK Tests and Deaths: **a total of 293,239 (1,866 since 14th July) were confirmed positive**. There has been a total of **45,233 (265 since 14th July) COVID-19 related deaths**.
- 14th July - In Southend-on-Sea there were **680 positive cases (8 new cases – Pillar 1 = 1 and Pillar 2 = 7 cases since the 14th July)**.
Pillar 1 (total 482) - tests carried out in NHS laboratories; **Pillar 2 (total 198)** - testing by commercial partners of the mass-testing programme.
- There were **187 confirmed deaths (1 new registered death since 14th July)** in both the hospital and community.

National Update

The government has issued new guidance to support Local Authorities with better containing local outbreaks. I have reviewed this in detail and I believe it is a robust framework that will both enable us to use additional local powers as well as clarity on how and when we can ask for national support, especially if issues are far too complex for us as a Council or we are unable to contain a growing outbreak.

Coronavirus (COVID-19) pandemic

21 July 2020

Purpose

This briefing is to update all on the ongoing development and management of the COVID-19 pandemic, including the current situation in the UK, and some key wider public health responses, mainly from a national level.

Latest on Coronavirus

- Risk Level – 3
- UK Tests and Deaths: **a total of 295,817 (2,578 since 17th July) were confirmed positive**. There has been a total of **45,422 (189 since 17th July) COVID-19 related deaths**.
- 20th July - In Southend-on-Sea there were **697 positive cases (17 new cases since the 17th July)**.
- There were **187 confirmed deaths (no new registered death since 17th July)** in both the hospital and community.

Access to Local Data going forward

After this Friday, 24th July, I am no longer planning to provide this update and will be moving to using our Coronavirus website to provide the new national website information and we will add the local deaths on the site on a weekly basis (these are now small numbers).

There is additional information (see screenshots below) provided on here such as the number of calls and triage via NHS 111, with more of testing shifting to Pillar 2.

Once on the site, please use the drop down menu to select 'Southend-on-Sea' and you can use the next drop-down menu to select different time intervals (in days – 1,3,7,10,14,30 and 60) or the total to-date (select 'All' – Table 1 below). If you select a time interval (say 7-day – see Table 2 below), you will also see how this has changed in the previous same time interval (here last 7 days).

Summary of the Govt. Announcements, 21 July 2020

Education:

- Guidance has been updated to now reflect that [early years settings can return to normal group sizes](#) and includes updated information about autumn funding, wraparound care, managing requests for site visits for new admissions in September, data collection changes, and reporting to Ofsted.
- Guidance has been updated outlining how councils can use their [dedicated schools grant \(DSG\) funding differently in exceptional circumstances during the coronavirus outbreak](#) and includes a section that sets out the government's plans for funding councils and providers in the 2020 autumn term.

HMRC are running free webinars over the next two weeks on the Eat Out to Help Out Scheme. [The webinar](#) provides an overview of the scheme, including how the scheme works, eligible establishments, registering and making a claim and what happens after a claim has been made.

1) Information Corner

Face coverings should be worn in shops and supermarkets from this Friday

Face coverings are already mandatory in healthcare settings, GP surgeries, hospitals and on public transport. They are also recommended when sharing cars with those outside of your household, and when you find yourself unable to maintain a 2 metre distance indoors with others from outside your household.

To be effective, face coverings should:

- cover both your nose and mouth
- fit comfortably but securely against the side of the face
- be secured to the head with ties or ear loops
- include at least two layers of fabric, ideally three
- unless disposable, it should be able to be washed with other items of laundry according to fabric washing instructions and dried without causing the face covering to be damaged

Users should heed the following guidance when putting on and taking off face coverings:

- wash your hands thoroughly with soap and water for 20 seconds or use hand sanitiser before putting a face covering on and before removing a face covering
- avoid wearing face coverings on your neck or forehead
- avoid touching the part of the face covering in contact with your mouth and nose, as it could be contaminated with the virus
- change the face covering if it becomes damp or if you've touched it
- only handle the straps, ties or clips
- do not share with anyone else
- if single-use, dispose of it carefully in a residual waste bin and do not recycle
- if reusable, wash it in line with manufacturer's instructions at the highest temperature appropriate for the fabric
- wash your hands thoroughly with soap and water for 20 seconds or use hand sanitiser once removed

The council's director of public health says: "Each and every one of us has a role to play in reducing the spread of the virus. This latest guidance on face coverings should ensure that community related transmission of the virus is further reduced.

"Coronavirus (COVID-19) is spread by droplets from coughs, sneezes and through speaking, shouting or singing. These droplets can also be picked up from surfaces, particularly if you touch a surface and then touch your face. This is why wearing a face covering is so important in controlling the spread of the virus.

“When used correctly, face coverings may reduce the spread of coronavirus droplets in certain circumstances. Because face coverings are mainly intended to protect others from coronavirus (COVID-19) they are not a replacement for social distancing and regular hand washing which remain as important as ever. However, if everyone wears a face covering in the settings identified, everyone is more protected, including yourself, and we can continue to reduce transmission rates. If you are not exempt, please remember to wear a face covering in shops and supermarkets from this Friday and continue to stay safe.”

Anyone experiencing coronavirus symptoms (high temperature, continuous cough or loss of or change in sense of smell or taste) should immediately stay at home, self-isolate with their household and visit www.nhs.uk/coronavirus or call 119 to find out how they can get tested.

Those who test positive for COVID-19 will be helped by the NHS test and trace service to identify the people they've recently been in contact with so they can be alerted.

People who have had close recent contact with someone with coronavirus must then self-isolate for 14 days, if they are advised to do so by the NHS test and trace service, to help contain the spread of infection.

Feeding the seagulls

We have been contacted by a member who has been annoyed by seagulls flying over her garden several times during the day. The member believes someone must be feeding them as she has seen the seagulls flying away with large chunks of bread in their beaks. They appear to have got used to being fed and they now expect the food during the day. The member has said that the seagulls are messing over her conservatory and her grandchildren were quite frightened when they visited her last weekend. They were having lunch in the garden and the seagulls were swooping over them.

The RSPCA advise people not to feed birds snacks like bread which is high in calories but otherwise of poor nutritional value. Feeding seagulls can result in over-population and the birds becoming a nuisance as they quickly learn where there are ready sources of food. They may even become aggressive to people if they realise that the public are likely to have food.

All in all, it is better for both people and seagulls if we refrain from feeding these seabirds. They do not prosper on a diet of bread and other scraps and quickly become a serious nuisance when they start pestering people for their next meal.

To be discussed in Parliament this week....Shock warning: Bored British teenagers are 'killing themselves' with laughing gas

New restrictions on the sale of nitrous oxide are needed to stop bored teenagers risking their health by using it as a drug, Parliament will be told this week.

Bored British teenagers are 'killing themselves' with laughing gas. Concern is escalating about the nerve damage that can be caused when the so-called "laughing gas" or "hippy crack" is inhaled.

Canterbury MP is alarmed at the sight of nitrous oxide canisters scattered across "parks, pavements and promenades" and a rise in antisocial behaviour. She has secured a debate to press for "fast action".

She claims it has been linked to 25 deaths since 2010 and is concerned at the ease with which teenagers can buy the canisters online. She said that we really need to further restrict how it is sold and distributed and education on why this isn't just harmless fun really needs to be ramped up at home and in schools."

New restrictions on the sale of nitrous oxide are needed to stop teenagers risking their health.

The drug and alcohol treatment manager at Public Health England, said the risks were “especially dangerous when mixed with alcohol”. He said the effects can include dizziness, confusion, loss of coordination, sound distortions and hallucinations. It is very difficult to judge how much you have used and the substance has been linked to a number of deaths.

The Government has said it has “no plans to change the law to make the possession of nitrous oxide for personal use an offence”.

However, the health minister stated this month: “Those who supply nitrous oxide who know, or who are reckless as to whether, it will be used for its psychoactive effect may be subject to a maximum sentence of seven years’ imprisonment, an unlimited fine, or both.”

Central Government announced they will be stopping centralised support including food parcels from 1 August. However, Southend-on-Sea Borough Council has decided to continue with the helpline and supporting those residents who need it.

The Southend Coronavirus Action helpline was set up by Southend-on-Sea Borough Council, in partnership with local charities and the voluntary community in response to the Coronavirus pandemic.

The aim is to support vulnerable residents who have no local support and are unable to leave their homes because of shielding or isolation, to get food supplies, medication, help with shopping or even dog walking.

Relying on volunteers to make it work, the helpline has shown the amazing community spirit of the town and created some otherwise unlikely friendships.

Telecoms giant BT is to move more than a million customers onto a new and 'more expensive' deal - as the company aims to simplify its pricing structure.

This is everything you need to know if you're a customer.

Which BT customers are affected?

The phone provider is moving 1.3 million landline customers over to its Unlimited Minutes plan, but this will add £4.50 a month to their costs.

In total, the price hike works out at an extra £54 each year.

The new deal will offer customers unlimited landline and mobile calls at any time, at a price of £15 a month instead of the usual £10.50.

However, the telecoms company calculates that the average person will only pay £1.83 more a month after the change. This is due to the savings customers will make on call charges.

When will the change take place?

BT said it is now writing to customers about the switch, with the change scheduled for September 1, 2020.

The company said that it was making the change in order to better suit how people use their phones now.

Can I move plans or leave BT?

If you don't want to pay the extra monthly cost or don't think it's the right plan for you to be on, then BT has said you can move to a different plan with the provider, or leave without being charged a fee to exit.

But customers should note that, in order to be able to move penalty-free, you have to let BT know your plans within 30 days of receiving the letter which tells you about the upcoming change.

Customers who have been identified as vulnerable and have a fixed voice service with BT, but no broadband, will not be moved over to the new plan.

What have BT said?

A spokeswoman from BT said: "If a customer is unhappy with the new package, we have other options available to replace their outdated plan, such as our Limited Minutes Plan, which includes 700 minutes to call UK mobile and landline numbers for a total of £7 a month or they can opt out for no cost."

2) Temporary Road Closure – Tylers Avenue & Clifftown Road, Southend-On-Sea – Essential carriageway works - 23rd July for 2 nights

Whilst this notice is in operation, all vehicles will be prohibited from:

Entering Tylers Avenue from its junction with Chichester Road to its junction with Clifftown Road; and

Whilst the works take place a Temporary suspension of the One-Way Street Order for Clifftown Road will be in place thereby making the Road Two-Way during the times stated to allow vehicular access to Central Station.

These prohibitions or restrictions will come into effect **on 23rd July 2020 for 2 nights from 20.30 hours to 05.00 hours the following morning.** This notice will remain in force for **5 days** to allow for unexpected events/delays and possible

remedial works. Whilst the closure and temporary suspension are in operation, a diversion route via Chichester Road, Queensway, A13 London Road, Milton Road, Cambridge Road, Scratton Road to the junction of Clarence Road will be in place.
