**Don't visit Southend. Please stay at home - if you are out for exercise, please stay safe and stay local**

The council is reminding visitors that all seafront parking remains closed and have urged them to stay away, and to stay home, protect the NHS and save lives.

Although the weather is set to be cold this weekend, the sun is due to be out on Saturday, and the council is reminding potential visitors to the Borough that we are still in national lockdown and people should be staying home and only leaving home

for a permitted reason. One of those reasons is exercise, but the council is urging people to stay local and not travel long distances to visit areas such as the seafront.

The Cinder Path between old Leigh and Chalkwell also remains closed for now.

Cllr Martin Terry, cabinet member for community safety, says: “The Government guidance is clear. People should not be leaving their homes unless absolutely essential and if they do leave home for a permitted reason such as exercise, they should always stay local – the Government says this means staying in the village, town, or part of the city where you live.

“I would also remind residents that they should not be travelling long distances for their exercise. We have lots of parks and open spaces across the whole Borough, so at the current time there should be no need to drive to visit the seafront and for now, please stay local and enjoy the areas close to you for exercise.

“We know the impact the national and these local restrictions are having on everyone, but we must continue to adhere to the rules, because we know the virus is still in our community and the new variant is more transmissible. We will be through this soon, and we will once again be able to welcome visitors back to our seafront, and other areas with open arms. But until then, please Don't visit Southend - stay at home, protect the NHS and save lives.”

Cllr Ron Woodley, cabinet member for transport, inward and capital investment, said: “We took the decision to close all seafront car parks from New Year's Eve because we were seeing large numbers of people congregating across the entirety of the seafront, including visitors from outside of the Borough. We therefore needed to take this difficult but right decision to deter this behaviour as best we could.

“Anyone that is parked in contravention of any restrictions will receive a parking ticket from our civil enforcement officers. I understand resident concerns regarding an increase in cars parked on residential streets, but would emphasise that the car park closures are only temporary, and we can hopefully reopen the car parks once it is safe to do so. We must all work together to reduce the spread of the virus whilst the vaccination roll out continues.”

## **Holocaust Memorial Day 2021**

In line with coronavirus restrictions, this year's Holocaust Memorial Day service of commemoration will be an online event, taking place on Tuesday 26th January, 6pm.

We are very pleased that Susan Bermange is the main speaker at the service. She attended the service in 2011 supporting her father "Bob" Obuchowski, himself a holocaust survivor, who spoke that year in our service. Susan will be talking about her father's experiences in Auschwitz, Buchenwald, Rhemsdorf and his death march, which he survived, to Thereisenstadt. The service includes a short piece of music, performed by the Southend Boys' and Girls' Choirs in 2018, and a filmed talk by holocaust survivor Eddie Jaku.

The Holocaust Memorial Tree will be planted on Wednesday 27th January on Marine Parade, Leigh on Sea (opposite Salisbury Road). This task will be carried out by our colleagues in the Parks Department, and there is no event for anyone to attend, due to the Coronavirus restrictions.

### **Over 400,000 crime records affected by error**

More than 400,000 fingerprint, DNA and arrest history records were accidentally deleted from the police national computer due to a coding error. Records related to serious offences that were to be kept indefinitely have also been lost, with police fearing criminals may not be caught. The Home Office said it was working with police to understand the impact of the mistake, which occurred during a "weeding" session to remove data.

The NHS sent out 641,000 invitations for jabs to people over 80 last week and another 380,000 this weekend.

A further 500,000 will go out this week along with, Ministers hope, the first invites for those in their 70s. Letters are being sent in special blue envelopes to reduce the risk of them being mistaken for junk mail.

### **Scam - COVID-19 vaccine booking scams**

Fraudulent text messages purporting to be from the NHS urging people to book a slot for their coronavirus vaccine are circulating. The messages include hyperlinks to fake websites that ask for personal information and bank details, before charging the individual for the booking. The Local Government Association has warned people to be vigilant against scam messages around the vaccination programme.

### **Essex Police Fraud Alert - NEW YEAR, NEW JOB? BEWARE FAKE RECRUITMENT ADVERTS**

As the impact of the pandemic starts to take its toll, many residents may find themselves having to look for a new job, and criminals are taking advantage of the high numbers of people now flooding the job market.

There are a four main types of recruitment scam including:

- Advance-Fee Scams—the ‘recruiters’ ask for upfront fees including security or police checks, immigration services for overseas jobs, and training programmes.
- Phone Scams—job seekers are asked to call a number and are kept on hold or subjected to a lengthy interview whilst unwitting paying a premium rate number
- Bank Details—fake recruiters ask for bank details claiming they need to register the victim on their payroll, but the information is used to steal money from the account
- Other Crimes—some fraudsters will manipulate jobseekers into committing crimes on their behalf whilst believing themselves to be working a legitimate job. For example, rather than ‘trading’ funds, jobseekers could actually be money laundering.

### I’m looking for a job, how can I protect myself?

The most obvious, yet effective way of protecting yourself from recruitment scams is simple:

Do your research.

- Make sure you have researched the company thoroughly before sharing any personal details such as date of birth, passport, National Insurance Number, driving license or bank details.

### WARNING SIGNS

- Poor spelling and grammar in the job advert, forms or documents
- Use of generic email addresses such as Yahoo or Hotmail instead of a corporate email address
- The ‘employer’ is adamant that they should make all the arrangements for you, including travel and accommodation

### **Brexit update - Act now to keep your business moving in 2021**

As the UK embarks on its new start as an independent trading nation, Business Minister Paul Scully has set out six key actions businesses must take to ensure they can seize all the opportunities on the horizon.

The zero tariff, zero quota trade deal the UK has struck with the European Union will help unlock investment and protect jobs across the United Kingdom and will allow businesses to benefit from new trade deals with partners all around the world.

However, there are a range of actions businesses must take in order to take advantage of these opportunities outside the customs union and single market. Today (18<sup>th</sup>), Minister Scully is urging businesses who have not yet taken steps to prepare for the UK’s new start to act now to avoid any potential disruption to their operations.

The six key actions many firms may need to take are:

- Goods - if you import or export goods to the EU, you must get an EORI number, make customs declarations or employ an agent to do them for you, check if your goods require extra papers (like plant or animal products) and speak to the EU business you're trading with to make sure they're completing the right EU paperwork. There are also special rules that apply to Northern Ireland. Hauliers must obtain a Kent Access Permit and have a negative Covid test before they head to port in Kent
- Services - if you deliver services to the EU, you must check whether your professional qualification is recognised by the appropriate EU regulator
- People - if you need to hire skilled staff from the EU, you must apply to become a licensed sponsor
- Travel - if you need to travel to the EU for business, you must check whether you need a visa or work permit
- Data - if your goods are protected by Intellectual Property (IP), you will need to check the new rules for parallel exporting IP protected goods from the UK to the EU, Norway, Iceland and Liechtenstein. You risk infringing on IP rights if you do not follow the new rules
- Accounting & Reporting - if your business has a presence in the EU you may need to change how you undertake accounting and reporting to ensure compliance with the relevant requirements

These six key actions should act as a guide for every business affected by the new rules, with more detailed, personalised advice available through the checker tool on [gov.uk/transition](https://gov.uk/transition).

To further support firms, today (Monday 18 January), the Business Department has launched a series of new, on demand videos to help businesses familiarise themselves with the new rules, which will be available via [gov.uk/transition](https://gov.uk/transition). Topics include importing and exporting, trade, data, and audit and accounting. Businesses can select which videos to view from the list, or can choose their sector and see videos that are recommended for them.

Many actions related to EU exit needed to have been taken regardless of the outcome of negotiations, and are therefore unaffected by the trade deal the UK has negotiated with the EU. However, in some areas, such as tariffs and audit and accounting, there is new guidance that businesses will need to familiarise themselves with.

The Business Support Helpline (0800 098 1098) is a free service operating across England. It can provide information on a wide range of business issues, including starting up, business continuity, growth and access to finance, including the range of business support available from Government. Similar services are available in Northern Ireland, Scotland and Wales.

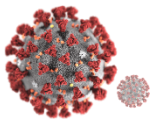

### **England's virus levels 'may have risen' in January, study shows**

Coronavirus infections in England did not slow down and may have increased instead in the first days of the latest national lockdown, an ongoing study has found. The Imperial College survey, conducted between 6 and 15 January, suggests one in 63 people were infected across England, an increase of 50 per cent on the last survey in early December. Researchers also said it will be weeks before the vaccine rollout has a substantial effect.

### **Summer lockdown not ruled out**

COVID-19 restrictions could continue into the summer, the Prime Minister has said, as UK coronavirus-related deaths continue to remain high. Ministers are wary of lifting restrictions too early as the country's mass vaccination programme is underway. Almost five million people now have their first dose of the vaccine, with 363,508 administered on Thursday – a new record.

### **Warning of cases spike if vaccinated people break rules**

People could become less strict at adhering to coronavirus rules as more of the population is vaccinated, scientists have warned. The Scientific Advisory Group for Emergencies said it could lead to a spike in cases which outweighs the gains made by rolling out the jab.

### **24-hour vaccination sites to be piloted in London before end of January**

Nadhim Zahawi, the Minister for COVID Vaccine Deployment, has said 24-hour vaccination sites will be piloted in London before the end of January. He told Sky News the NHS will be "targeting forensically who we want to protect" to ensure the most vulnerable can be vaccinated first.

## **Oxford scientists preparing new vaccine versions to combat emerging COVID-19 strains**

Oxford scientists are preparing to rapidly produce new versions of their vaccine to tackle emerging COVID-19 strains from the UK, South Africa and Brazil, following new research which suggests that the current generation of coronavirus vaccines may not work against the new South African strain.

## **Plans for daily coronavirus testing in schools put on hold**

The Government has paused plans to roll out rapid daily coronavirus testing of close contacts in schools, other than for schools involved in further evaluation. Public Health England said the balance of the risks and potential benefits of daily testing were “unclear” after the emergence of the more transmissible variant of COVID-19.

## **All UK travel corridors closed from Monday**

All international arrivals will need to provide evidence of a negative coronavirus test and quarantine upon entry from Monday, as the UK tighten their measures amid increasing pressures on the NHS and fears of a new variant. Despite some initial signs that infections may be levelling off, the UK recorded a further 55,761 cases on Friday (15<sup>th</sup>) and another 1,280 people have died.

## **Delay of Pfizer vaccine to the UK**

The UK is one of several countries facing delays in delivery of the Pfizer/BioNTech COVID-19 vaccine as the company upgrade its production capacity, in an effort to produce more doses than planned in 2021. The UK has secured 40 million doses of the Pfizer vaccine, but shipments are set to be affected this month.

## **Doctors throwing away leftover vaccines**

GPs are being forced to throw away leftover vaccines rather than giving second doses, medics have revealed, with some fearing a cancellation of their supplies if they don't follow instructions. Due to the uncertainty of the supply chain, GPs say they are finding it difficult to book the exact number of appointments for their clinic, and that local NHS managers are enforcing a “strong decree” from NHS England that no one should receive a second dose too literally.

## **Vaccinations to begin for over-70s in England**

People in England aged 70 and over, and those listed as clinically extremely vulnerable, will start to receive offers of a COVID-19 vaccine this week. Over five million people – from priority groups three and four – will be invited to have the jab from Monday. Latest figures show the UK recorded a further 671 deaths within 28 days of a positive test and another 38,598 positive tests.

## **All adults could be vaccinated by June**

All over 18s could have the COVID-19 vaccine by the end of June, with a target of administering four to five million vaccines a week now realistically possible, Whitehall sources say. The Government are reluctant to publicly acknowledge a deadline, but

believe that with the further two vaccines from Moderna and Johnson & Johnson in the pipeline, the process to give all 54 million adults a jab can be done by June.

## **Ten more mass vaccination centres to open in England**

A further ten mass vaccination centres are set to open from Monday and will offer “thousands” of jabs a week, NHS England says. The Government promised that all over-70s, extremely clinically vulnerable and frontline health and care workers would receive a first jab by 15 February. More people have now received a COVID-19 vaccine in the UK than have tested positive for the virus.

## **All supermarkets to face safety protocol inspection**

All supermarkets will face inspections in the next two weeks to make sure they are Covid-secure. Ministers have reportedly told councils to check supermarkets have effective safety measures in place. A checklist drawn up by the LGA includes restricting capacity, signs and measures to make sure people are wearing masks, one-way systems with markings, hand sanitisers and staff wearing masks.

## **Weekly Briefing on Local Decisions & Actions re Coronavirus outbreak 15<sup>th</sup> January 2021**

### **Key updates/actions**

**Vaccination:** Now that more doses of Covid-19 are available, the NHS is able to open more vaccination services, including the first vaccination centres. Vaccination centres mark the next step in rolling out the COVID-19 vaccinations in mid and south Essex. These centres are the important third strand of the NHS Covid-19 vaccination plan, sitting alongside hospital hubs and local GP-led vaccination services, both of which will continue to grow in number as the supplies of vaccine available to the NHS continues to grow. More details are on the EPUT website. The key messages from the NHS on the vaccine are as follows:

- Please don't contact the NHS to seek a vaccine, they will contact you;
- When they do contact you, please attend your booked appointments on time – please avoid arriving early as the NHS want to avoid queues;
- Please continue to follow all the guidance to control the virus and save lives.

**LFD testing sites:** From next week, the Council will have 3 rapid testing sites open across the Borough:

Shoebury youth centre site will open on Tuesday 19th January from 3.30-7pm and from 8am to 7pm from Wednesday onwards. People need to book an appointment via MySouthend. Read the media release on our website.

University Square site in central Southend is open from 7am to 3pm, seven days a week. People need to book an appointment via MySouthend.

St Aidan's Church site in Leigh-on-Sea is open from 7am to 6pm, seven days a week. People need to book an appointment via MySouthend.

**Act like you have it – Don't spread it:** We are upping our messages to promote the national lockdown message and urging people to 'Act like you have it – don't spread it.'

**Stay at Home resources:** New national social media assets for the stay at home message have been published on the PHE Coronavirus resources website.

**Free school meals:** The Council has spent £190,000 to fund free school meal vouchers over the last two weeks. This investment has supported local schools and local families through the initial national lockdown period. In addition, the Council will fund free schools meals through the February half-term via the winter COVID grant scheme funded by the Government as announced before Christmas.

**Compliance:** Officers are continuing to visit supermarkets/smaller food shops/newsagents across the Borough and will continue this weekend to provide COVID support and advice to these stores. The Council is part of the Ministry of Housing, Communities and Local Government (MHCLG) Compliance Working Group. The aim of this group is for local authorities to inform central government of the main issues and discuss potential solutions around retail compliance to be led top down by central government and support work at a local level. The Council was invited due to the proactive work we have done with supermarkets around risk assessments and compliance.

**Coronavirus case data:** This is published on our website and now also includes the daily 7 day rate of positive cases per 100,000.

7-day rate of positive cases as of 15 January is 910.3 per 100,000 (down from 1,219.9 per 100,000 on 8 January). The rate in the 60 and over age bracket is 800.2 per 100,000, down from 969.4 per 100,000 on 8 January.

**ONS death data:** Southend-on-Sea residents' deaths registered inside and outside of Southend-on-Sea with any mention of COVID-19 on the death certificate that occurred up to 1 January 2021 but were registered up to 9 January 2021: 330 (+45)

**National and local data:** A link to the national NHS Digital information shows information by time intervals (for example, 3-days, 7-days, 30-days, etc), as well as the total numbers and requests or referrals to NHS 111.

## **DfE has published:**

New advice that the national free school meal voucher scheme will go live from 18 January. Schools will be able to place orders for supermarket gift cards on behalf of the parents and carers whose children are eligible for benefits-related free school meals, to cover the period between 18 January and 12 February (4 weeks). As well as using the national voucher scheme, schools still have the option of providing food to eligible pupils via a lunch parcel, through a caterer or food provider, or via a locally arranged solution. This could include providing vouchers for a local shop or supermarket, or sourcing vouchers through an alternative provider. For those arranging vouchers locally rather than through the national voucher scheme, more details will be available soon on how you can claim back these costs. Beyond the fact that it will need to be a valid claim based on eligible children and support provided over the specified timeframe, claims will not be subject to any additional criteria and so will be paid in full. The rates are £15 for vouchers or a £3.50 top up if you are providing lunch parcels. These amounts are per week, per eligible child.
