### 1) Information Corner

Essex Police Fraud Alert System - FLUBOT—ANDROID USERS BEWARE Guidance has been issued but the National Cyber Security Centre (NCSC) about 'FluBot' - spyware affecting Android phones and devices that is delivered via the package delivery messages covered by a previous alert.

The spyware is installed when the text message asks them to install a tracking app due to a missed package delivery (currently these scams claim to be DHL but the brand could change). The app is the spyware and will steal passwords and other sensitive data, as well as accessing contacts to send out more text messages.

If you have already clicked the link to download the application:

- Do not enter your password, or log into any accounts until you have followed the below steps.
- To clean your device, you should:
- Perform a factory reset as soon as possible. The process for doing this will vary based on the device manufacturer and guidance can be found via the NCSC website. Note that if you don't have backups enabled, you will lose data.
- When you set up the device after the reset, it may ask you if you want to restore from a backup. You should avoid restoring from any backups created after you downloaded the app, as they will also be infected.



- To protect your accounts:
- If you have logged in to any accounts or apps using a password since downloading the app, that account password needs to be changed and if you have used these same passwords for any other accounts, then these also need to be changed.

#### Fireplaces worse than traffic for pollution

Fireplaces and stoves are now the largest single source of primary particle pollution in the UK, with about 40 per cent of the country's total coming from just seven per cent of homes. A ban was introduced last week on sales of coat and wet wood in England as traffic and industry is overtaken by this pollutant.

# Census 2021 text scams UK: Which? issues urgent warning over online scam that could cost you £1,000

We have been contacted by a member as he has received a Census scam text that sounded genuine.

Which? has issued an urgent warning over an online scam related to the 2021 Census.

The UK consumer champion says it's seen several variations of a census scam circulating online.

The census is a survey about all the households in England and Wales, and Census Day was held back on Sunday, March 21.

It's filled out every 10 years and it's the law for everyone to complete the census and provide accurate information because it helps decide how services are funded in your area.

But an online scam is said to be fraudulently targeting some members of the public.

Which? says any letters, phone calls, texts or emails attempting to take payment for a late or incorrect census submission are scams and has reminded people to remain vigilant.

#### Fake COVID-19 vaccine cards sold online for as little as £5

Fake vaccine cards have been sold online for as little as £5, prompting fears that some travellers could cheat COVID-19 passport schemes. The cards – almost identical to those given out by the NHS to people who have received jabs to protect them against the virus – can be customised with details to falsely show a person has received a specific vaccine and the date on which it was administered.

#### Under 40s to be offered alternative jab

People under 40 will be offered an alternative to the AstraZeneca vaccine due to concerns over rare blood clots. To date, more than 51 million vaccines have been administered in the UK and the Medicines and Healthcare products Regulatory Agency (MHRA) has reported 242 cases of clotting, including 49 deaths.

#### School face mask rule may be lifted

Secondary school students may not be required to wear a face mask in school as part of the third step of the Government's roadmap out of lockdown. Restrictions are set to ease further on 17 May and this date could signal the end of masks in school, despite a group of teaching unions and scientists asking for a delay until 21 June. An estimated 43,000 children and 114,000 school staff are thought to be currently suffering from long COVID.

#### **Key updates/actions**

#### Vaccination:

With the vaccination roll-out underway, regular information is being updated on the EPUT website and the dedicated Essex COVID vaccine website. Figures are now also being reported by the national programme on a STP/ICS footprint – the latest weekly figures can be found at https://www.england.nhs.uk/statistics/statistical-work-areas/covid-19-vaccinations/.

#### COVID-19 testing:

**General:** Testing options includes two rapid testing **LFD** sites available across the Borough, with the Shoebury Youth Centre site closing today. The LFD rapid testing and some local PCR testing sites are operating as collection points for symptom-free home



testing kits. Kits may also be collected from selected pharmacies and local libraries.

Full details of all the booking and walk-up options are available at www.southend.gov.uk/gettested Testing is key to stop the spread and identify cases.

Reminder on Community Collect: Rapid Covid-19 self-test kits are being offered to everyone living and working in Southend-on-Sea under the Community Collect initiative to support the Government's roadmap out of lockdown. Read the media release on our website.

#### Business grants:

Business grants in place from November lockdown: 7,466 grant payments totaling £16.68m

Restart Grants: 767 grant payments totaling £6.02m

Discretionary grants: Paid £1.941m to 611 businesses

Small business and Retail, Hospitality and Leisure grants: Paid c. £37.5m to 3,086 businesses

#### Phase 2 of Additional Restriction Group (ARG):

Applications are now being welcomed for phase 2 of the ARG allocation for the borough, which is open to businesses that can demonstrate business related costs and a reduction in their income of at least 25% as a result of COVID-19, from 5 November 2020, as well as taxi drivers licenced by Southend-on-Sea Borough Council. This includes both businesses that appear on the **MHCLG** Business Rates Rating List and those that do not.

#### Coronavirus case data:

This is published on our website and now also includes the daily 7 day rate of positive cases per 100,000.

**7-day rate** of positive cases as of **7 May 2021 is 9.8 per 100,000** (down from 12.6 per 100,000 on 30 April). The rate in the **60 and over age bracket is 4.4 per 100,000** (down from 11 on 30 April).

#### ONS death data:

Southend-on-Sea residents' deaths registered inside and outside of Southend-on-Sea with any mention of COVID-19 on the death certificate that occurred up to 23 April but were registered up to 1 May 2021: **673 (+1)**.

#### National and local data:

A link to the national NHS Digital information shows information by time intervals (for example, 3-days, 7-days, 30-days, etc), as well as the total numbers and requests or referrals to NHS 111.
