Roofing contractor caught damaging footway

The Highways Enforcement Team proactively patrol the highway network looking for instances of damage or interference to the public highway. Recently, one officer spotted a private roofing contractor had damaged and subsequently attempted an illegal repair of the footway. The officer intervened and spoke with the contractor who admitted liability after some discussions. The Enforcement team will now be seeking to recover all costs from the third party.

Special operation at Eastern Avenue

After numerous complaints to both Southend-on-Sea City Council and the Police regarding non-compliant parking and alleged threatening behaviour, a 'special operation' was planned at McDonalds near Eastern Avenue on Friday 24th June 2022 to support the local residents and to promote engagement/education with food delivery drivers.

Issues in the area occur due to McDonalds becoming busier with delivery drivers parking in the surrounding area of the restaurant, and this has caused inconvenience for the residents getting in and out of the slip road. There are double yellow lines along the area that passes McDonalds, however, non-compliant parking is still common. Unfortunately, when residents have spoken to drivers, there have been allegations of threatening behaviour and although this area is covered by Civil Enforcement Officer (CEO) patrols, the drivers are reported to be moving their vehicles before a Penalty Charge Notice can be issued but then returning to the site after the CEO has left.

The Highways & Parking Technical Operations Team Leader planned the operation with a team from APCOA (parking enforcement contractor) to attend the area on possibly the busiest night of the week for takeaways. This was coordinated to help support the residents and where possible, engage with the food delivery drivers.

The team arrived at 4.30pm to make sure they were in place for the start of the busy Friday rush for takeaways and stayed on site until 8.30pm when things started to slow down. The object of the operation was to keep the entire area free from non-compliant parking and to engage with drivers explaining why the operation was taking place.

The team were greeted with numerous comments of 'thanks' from the residents who were grateful that they could drive to their homes without negotiating large numbers of vehicles parking on the double yellow lines.

The operation was a success, and the area was clear of non-compliant parking and residents were able to access their properties freely throughout the evening. Unfortunately, this type of operation does take resources from other areas and isn't something that is sustainable regularly, but the Parking team hope that these special operations will help deter non-compliant parking in the future.

What do you do if you are in receipt of a PCN?

In the case of a PCN being issued, you will need to follow the PCN appeals process.

If you wish to challenge your Penalty Charge Notice (PCN), you can do this using our online form.

If you challenge a PCN, the case will be placed in a queue for consideration. No action will be taken or further charges applied until we have considered the comments and responded to the offender in writing. We appreciate your patience as this process can take between 4 to 6 weeks and even longer during busy periods.

City Fibre updates

City Fibre are still working hard to install fibre optic services for residents around Southend-on-Sea.

City Fibre are currently working on London Road, which they need to complete a majority of the wards in this area. They are moving on to Leigh-on-Sea Broadway and surrounding areas shortly.

Arriva Bus Service Changes (effective 17 Jul & 24 Jul 22)

From 17th July 2022 the following changes will be in place:

Route 4A - Landwick to Southend City Travel Centre. The frequency for this service is 2 hourly (Sundays only) The revised route the service now operates from Landwick via Asda, North Shoebury Road, Bournes Green Chase, Southchurch Road to Southend Travel Centre. This will be operated on behalf of Essex County Council.

Then, from 24th July 2022 the following changes will be in place:

Route 1 will be split into Route 1 and Route 2 to improve punctuality of the service.

Route 1 - Southend City Travel Centre to Rayleigh Station. This service will now only operate between Southend and Rayleigh, The frequency will be up to every 10 minutes Monday to Friday, up to every 12 minutes on Saturdays and up to every 30 minutes on Sundays

Route 2 - Southend City Travel Centre to Shoeburyness. This service will replace service 1 between Southend and Shoeburyness, The frequency will be up to every 12 minutes on Monday to Friday, and up to every 15 minutes on Saturdays and up to every 30 minutes on Sundays.

Route 6 – Southend City Travel Centre to Temple Sutton. The route will operate up to every 30 minutes Monday to Saturday and hourly on Sundays

Route 7/8 – Shoeburyness or Landwick to Rayleigh Station . The core frequency of this route will reduce to every 20 minutes Monday to Saturday, every 30 minutes between Shoeburyness and Rochford on Sundays. Route 7- Serving Ashingdon will operate through the main part of the day with 2 buses an hour Monday to Saturdays, every hour on Sundays. Route 8 Serving Hawkwell will operate hourly Monday to Saturday and no service Sundays, Buses for Wakering and Landwick will operate up to every 40 minutes Monday to Saturday. Service 4A will operate every 2 hours on Sundays for Wakering and Landwick.

Route 9 – Shoeburyness East Beach to Rayleigh Station. The frequency will be up to every 15 minutes Monday to Saturday, up to every 30 minutes on Sundays

Route 29 – Southend City Travel Centre to Belgrave Road. The route will operate up to every 30 minutes Monday to Saturday and hourly on Sundays

2) National Corner

COVID-19 infections increase

The number of people in the UK with COVID has risen to almost 2.3 million, up from 1.7 million people the previous week and the highest estimate for total infections since late April. Rising UK infections come amid a warning from the World Health Organisation that the pandemic not over.

COVID-19 booster for all over-50s

All over-50s are likely to get another coronavirus booster in the autumn to avoid winter pressures on the NHS, it has been reported. An extra six million middle-aged people are expected to be offered a fourth dose as an Omicron sub-variant continues to push up cases and hospital admissions.

8.6 million parking tickets issued by private firms

Drivers have been handed 8.6 million parking tickets across Britain by private firms in the last 12 months up by 50 per cent compared with four years earlier. An average of 23,000 tickets a day were issued between April 2021 and March 2022, according to data from the Driver Vehicle Licensing Agency.

Residents to vote on street names

Residents will be able to vote down proposed changes to street names under a new law to prevent the removal the names of controversial figures from signs. The Government is to announce new legislation that will require all councils in England to consult with residents and businesses and hold a vote on any suggested name changes.

Mandatory masks on hospital wards

Hospitals are reintroducing mandatory masks and social distancing as they deal with 10,658 patients in hospital with the virus yesterday, up from 3,835 on June 4. It is likely that hospital admissions in the latest wave, driven by the BA.4 and BA.5 Omicron sub-variants, will exceed this year's previous peak of 16,600 patients in April.

Two million workers will no longer pay National Insurance

More than two million low-income workers will no longer pay National Insurance from now, owing to a change in the way the tax is collected. Employees can now earn £12,570 a year before paying National Insurance, up from £9,880 a year previously.

E-scooter trials extended despite spike in pedestrian injuries

Trials of e-scooters have been extended by 18 months despite a surge in the number of pedestrians injured by the contraptions. Transport minister Trudy Harrison announced that English local authorities have the option of continuing pilot schemes for rental e-scooters until the end of May 2024, which will allow the Government to "gather further evidence where gaps are identified, building on the findings of the current evaluation".

Vaping among children doubles in two years as experts blame TikTok

Vaping among children and teenagers has almost doubled in two years, data suggests, with experts blaming the rise on people using disposable e-cigarettes on



TikTok and Instagram. The survey of children, carried out for the Action on Smoking and Health charity, showed that seven per cent of 11- to 17-year-olds are vapers, up from four per cent in 2020.
