## When Arriva bus drivers are set to strike in Southend

Unite officials said around 800 bus workers at Arriva in Kent and Essex would be striking over a "pay cut presented as rise". The union said staff voted to strike after Arriva offered a 7.8 per cent pay increase.

Arriva bosses described the offer as "generous," but union representatives said the bus firm is "prioritising paying shareholders over decent wages for workers".

It expects to run a limited service in Southend on Monday, September 5, when drivers will be striking. However, bosses say they will provide a further update throughout Monday morning.

# Calls for fly-tipping fines to rise

Fines for fly-tippers should be raised to "significant" levels to act as a suitable deterrent and hold those responsible accountable, Cllr David Renard, leader of Swindon Borough Council has told the Government. Fly-tipping incidents across the country hit almost one million in 2020, now costing taxpayers in England nearly £50 million a year to clear up. The LGA said while the Government allows unlicensed disposal firms to be fined up to £5,000, those prosecuted for the worst dumping offences were handed an average fine of just £335 in 2020/21.

# River pollution targets set

A plan to reduce sewage discharges into England's rivers and the sea has been announced by government, promising the "strictest targets ever." Pollution warnings were in place on nearly 50 beaches last week following heavy rainfall leading to water companies dumping untreated sewage. The plan will require water companies to invest a total of £56 billion over 25 years in the "largest infrastructure programme in water company history."

# "Toilet-to-tap" drinking water plans

Water companies are planning "toilet-to-tap" water recycling systems, to turn sewage from lavatories into drinking water, according to the head of the Environment Agency. Sir James Bevan said people need to be "less squeamish" about drinking water taken from sewage plants, and that the "unpopular" move would help protect the UK's water supply.

## Councils warn of soaring costs of road repairs

Councils are warning of the soaring cost of road repairs and street lighting due to rising inflation and the war in Ukraine. Analysis by the LGA and ADEPT found that councils had faced a 22 per cent spike in the cost of road maintenance in the last six months, with a 38 per cent increase in the bill for running and repairing street lights, with some councils having seen their costs double. Before the invasion in February, around 60 per cent of bitumen used in Europe was sourced from Russia.

## 'Warm banks' being set up for winter

Facilities such as churches, community centres and libraries will be available for people to stay warm during the winter months across parts of the country, as the cost of energy soars. The LGA said that while local authorities were doing "all they can", "warm banks" were "not alternatives" to providing householders with "adequate resources" to make heating homes affordable.

## Rail workers to stage two days of fresh walkouts, RMT union say

Rail workers will hold fresh strikes in a long-running dispute over pay, jobs and conditions, the RMT union has said. It said 40,000 of its members who work at Network Rail and 14 train companies will walk out on 15 and 17 September, with the first day of these strikes coinciding with a walkout by train drivers at 12 rail companies organised by the Aslef union.
