#### Scam Alert - British Gas refund

Beware of a phishing email which appears to be from British Gas.

The scam claims you are due a refund for overpaying in 2020-21 and will ask you to follow a link to claim the refund of £315.

The email generally contains a fake 7-digit reference that starts with BG and the British Gas Logo.

If in doubt about an email, contact the organisation directly and do not click on any links.

The legitimate organisation will be happy to help you and not pressure you into providing unnecessary information.

#### **Lest we forget – Remembrance Sunday Service and Parade**

Southend-on-Sea's annual Remembrance Sunday commemoration service will take place on Sunday 13 November at the Cenotaph on Clifftown Parade.

Everyone is invited to attend the Remembrance Day Service to honour and pay their respects to those who laid down their lives in the World Wars and other conflicts since.

At 10.15am, the Parade will assemble in Prittlewell Square leading to the Cenotaph. At 11am, the chimes of Big Ben will commence the service, followed by a bugler sounding 'The Last Post' and then there will be two minutes' silence.

The Worshipful The Mayor, Cllr Kevin Robinson will then lay a wreath at the Cenotaph, followed by dignitaries. The Cross of Remembrance will then be placed on behalf of war widows, alongside wreaths laid by emergency services and faith community representatives.

The Mayor's Chaplain, Reverend Claire Abraham and the Archdeacon of Southend, The Venerable Mike Power, will lead the service, during which the Veterans Associations will lay wreaths.

Hymns and other musical contributions during the event will be played by Southend Citadel Band of the Salvation Army.

A number of road closures will be in place in the area surrounding the Cenotaph to accommodate the parade and the service. These closures will be lifted once the service has completed and will be clearly signposted. Any cars found parked within the closures will be lifted to Alexandra Road, so please ensure all cars are removed from the closure areas ahead of the service.

Those who cannot attend the event can follow the service live on the council's social media accounts.

### 2) National Corner

#### Council tax bills could rise

The cap that prevents council tax from being raised by more than two per cent a year without a local referendum could reportedly be relaxed by Chancellor Jeremy Hunt. The Government are looking to find around £50 billion in tax rises and spending cuts ahead of the Autumn Statement. It is reported that government could give councils



greater tax rising powers to bring in money to compensate for government spending cuts. The LGA has warned ministers that councils already face a £3.4 billion funding gap next year to "maintain services at pre-Covid levels." It said council tax would need to rise by more than 10 per cent just to plug that gap, which would be neither "sustainable or desirable."

#### Discounts for off-peak electricity usage

Energy regulator Ofgem has officially approved a National Grid scheme that will offer discounts to customers who cut their electricity usage during peak times. British Gas owner Centrica, E.ON and EDF will follow Octopus Energy in participating in the scheme which could save households £100 on their bills this winter and reduce the risk of national power outages.

#### COVID-19 cases fall

Cases of COVID-19 have fallen in England, Wales and Scotland for the first time since September, latest figures from the Official for National Statistics suggest. Infections across the UK as a whole fell from 2.05 million people testing positive outside of hospitals and care homes for the week ending 17 October, to 1.87 million the following week.

#### Calls for private litter enforcement

Councils should bring in private enforcement services to tackle litter, according to think tank Bright Blue. Fly-tipping cases have risen to 1.13 million each year, up 16 per cent from 2019/20, and an estimated two million pieces of rubbish are dropped across the country every day. An LGA spokesperson, said: "In some instances, bringing in private companies may be better value for the public, and avoid the cost of littering being passed on to responsible residents. Each council has to decide the best way to tackle litter in their individual communities, but whilst we recognise that responses have to be proportionate, measures must be robust enough to tackle abuse of the local environment."

#### Bill of Rights to be reintroduced

Prime Minister Rishi Sunak will reportedly bring back the British Bill of Rights as part of his plan to prevent migrants from crossing the Channel. A legal challenge under the European Convention on Human Rights saw the first flight of asylum seekers set for Rwanda grounded earlier this year, but the introduction of a new law could secure the supremacy of UK courts over Strasbourg.

#### Two-and-a-half-day ambulance wait

Patients are having to wait up to two and a half days for an ambulance, according to a Freedom of Information request. The data reveals delays of more than 24 hours for conditions such as heart attack and strokes, with the longest delay experienced being 59 and a half hours.

#### Schools axe staff to balance books

A survey of more than 11,000 school leaders in England by the NAHT union has found the majority of schools face having to lay off staff or reduce hours to stay afloat. It found more than 9 in 10 schools won't be able to balance the books without drastic cuts.



#### Pay-outs to pothole injury victims cost councils £32m in five years

Figures show councils have paid out more than £32 million in compensation to people injured by potholes in the past five years. A total of 157 councils in England and Wales who responded to a Freedom of Information request by Lime Solicitors settled 5,596 personal injury claims in relation to potholes between 2017 and 2021.

Three out of five drivers believe local road conditions have worsened Three out of five drivers believe the condition of local roads has deteriorated in the past year, a survey by the RAC has found. Just 4 per cent of the 3,102 motorists polled for the RAC said the roads in their area have improved. Cllr David Renard, Transport spokesman for the LGA said: "Despite the efforts of councils, which repair a pothole every 19 seconds, our local roads repair backlog is rising, with latest estimates showing it would take over £12 billion and 10 years to clear. Councils across the country are facing unprecedented increased costs to repair our local roads, keep our street lights switched on and invest in improved local infrastructure."

#### University staff to strike

University lecturers and other staff across the UK will strike this month over pay, pensions and working conditions. Strikes will take place on 24, 25 and 30 November at 150 universities, and 70,000 staff members will strike. The Royal College of Nursing is expected to announce today (9<sup>th</sup>) that nurses have voted to take strike action in many parts of the country.

#### Nurses across UK back strikes in pay dispute

Nurses across the UK have voted to strike over pay with action expected to start by the end of the year. The walkout will involve Royal College of Nursing members in more than half of hospitals and community teams, but emergency care will still be staffed.

# Food banks at 'breaking point' as 1.3 million emergency parcels given out in just six months

Food banks are being driven to "breaking point" with almost 1.3 million emergency parcels given to people in just over six months, a leading charity has said. The Trussell Trust said almost half a million of the food parcels given out went to children after new research showed record-breaking levels of need, with 320,000 being forced to turn to food banks for the first time in the last six months.

#### Antibody jab approved for common winter virus RSV

A new treatment to protect babies against a common and potentially dangerous winter virus has been approved by the UK regulator. The single antibody shot helps stop infants getting chest infections, such as pneumonia, for about six months and a large study has now begun to find out whether nirsevimab should be offered to all babies in the UK.
