We're gritting in the spirit of winter

The council and its street cleansing and winter maintenance partner Veolia are ready to be called into gritting action, so residents and visitors can travel around the City safely in the cold weather this winter.

Veolia's three gritting vehicles are ready to be called out when needed. Alongside 122 salt bins for residents and businesses to make use of across the City, there's also over 1,800 tonnes of salt in reserve.

The 'main route' gritter spreads nine tonnes of salt per operation and two smaller gritters cover additional routes and both spread five tonnes of salt each per operation.

As well as the roads, Veolia uses small gritting vehicles to keep priority pavements and walkways safe across the Southend-on-Sea.

The council is looking for local residents to support their own communities by becoming a snow warden and committing to grit local pavements and driveways. Free gritting equipment is available to Southend residents who sign the pledge, and a first giveaway session will be taking place between 10am and 3pm at Stock Road Recycling Centre on Saturday 2 December to find out more visit www.veolia.co.uk/southend/snow-warden

Use the MySouthend platform to report potholes this winter

The combination of wet and cold weather can affect our roads and pavements as potholes are formed through the freezing and thawing of water. This winter, please use the MySouthend platform to report any potholes. It is the quickest way to ensure your report gets inspected. The defect will be inspected within 24 hours or next working day. Highways inspectors will be working throughout the festive period.

The current investigatory levels for a pothole in the road are 40mm deep by 300mm, and for pavement potholes it is 20mm deep by 600mm. Please bare these measurements in mind when reporting a defect so that our inspectors can prioritise the most severe reports this winter.

100,000 nurses to strike next month

Up to 100,000 nurses will strike next month at NHS employers including cancer and children's hospitals, it has been reported. In England half of the trusts that voted in favour of strikes will participate in this round of action whilst all but one NHS employer will strike in Wales.

E-scooter campaigners call for government to pause trials following deathsCampaigners have called on the Government to immediately pause its e-scooter trials as new figures reveal that the number of people killed in e-scooter crashes has tripled in the last years. Data from the Department for Transport shows 12 people

died in incidents involving e-scooters in the year ending June 2022.

Ultra Low Emissions Zone to cover all of London

London's Ultra Low Emissions Zone is to be expanded to cover all of London. Drivers of some cars will have to pay £12.50 a day to enter to the Greater London Authority boundary from 29 August 2023.

Thousands spending over 12 hours in A&E

The head of the Royal College of Emergency Medicine has warned that around 4,000 patients a day are spending more than 12 hours in A&E as the emergency care system "collapses". Dr Adrian Boyle's comments come as nurses prepare for their first national strike in history, with two days of action planned before Christmas.

Military may drive ambulances and staff hospitals

Armed forces personnel could drive ambulances and stand in for frontline hospital roles, under emergency plans to deal with a possible winter of strikes. Health and defence officials are reportedly drawing up contingency plans for the Government to invoke the military aid to civil authorities protocol (Maca), as ambulance drivers and paramedics consider joining nurses on the picket lines in the coming months.

Infectious migrants will be told to isolate in hotel rooms

Migrants with suspected infections of highly contagious diseases will be ordered to isolate in their rooms to prevent them spreading to the general population. Emergency public health guidance has been issued to hotels following growing outbreaks of skin infections such as diphtheria, scabies, group A Strep and MRSA, respiratory infections such as flu and Covid-19, and gastrointestinal infections such as norovirus.

Just Stop Oil protesters planning disruption in run-up to Christmas, police warn

Further disruption is threatened by Just Stop Oil protesters in the run-up to Christmas, Scotland Yard has warned. The Metropolitan Police has moved to reassure the public that the force is "fully prepared" to deal with the climate activists and urged people not to take matters into their own hands, in the face of growing frustration and anger at their tactics.



Alzheimer's drug lecanemab breakthrough

The first drug to slow the destruction of the brain in Alzheimer's has been discovered after trials. The drug, lecanemab, slows down the progression of Alzheimer's in its early stages.

One in 26 trains cancelled this year

Newly released data from the Office of Road and Rail shows 3.8 per cent of trains in Great Britain have been cancelled in the year up to 12 November - or one in every 26. The Transport Secretary Mark Harper is due to meet a group of metro mayors today to discuss the situation.
