Spread it, Sign it, Stop it

Following on from today's letter, please see below some of the comments that I have received from residents regarding the truck movements. Please do not forget to sign the ePetition at <u>https://democracy.southend.gov.uk/mgEPetitionDisplay.aspx?id=69t</u> before the 31st January 2023.

'I am absolutely amazed at the decision to allow such a massive movement of vehicles and related waste / spoil along our already crumbling roads. The pollution in a residential area which includes schools is also unacceptable'

'In looking at the situation why cannot they barge the loads to the barge pier. This pier is right next to the site'

'Thank you for speaking against the application on behalf of residents. It looks like the implications for this area will be massive'

'I have another more important issue for residents in Thorpe Hall and surrounds and that's the impact from constant ground vibration that over a 2.5 year period will cause wall cracking and roof tile loosening. A petition needs to be supported by all Thorpe and Southchurch residents to stop this madness'



'I share your concern at this decision and even more at the building of yet more houses without any corresponding improvement to local infrastructure such as road improvement in what is becoming an over developed and under resourced/serviced part of the City'

'Well, it sounds quite dreadful. We can't believe that councillors have voted for such a dreadful plan. Please accept our thanks for voting against it'

'That drainage system at the junction of Thorpe Hall Avenue and Eastern Avenue which has frequently failed over the last several years will not cope with heavy trucks traversing that corner'.

'I had to pinch myself that this was not an April Fool's joke. The level of damage to local roads built for domestic traffic will be considerable - who will pay? The increase in hazard on local roads will be significant and it's a pipe dream to think that lorries will run separately at 5 min intervals, there will surely be many instances of a convoy of lorries. I cannot believe that Councillors have approved this - they obviously have no regard to the residents affected by this. And thank you for being the only councillor who cares'

'I totally agree with your comment in today's Echo regarding the proposals as being "ridiculous".

'We very much support your objection to this outrageous proposal. Could more use be made of the Estuary to transport this material to avoid clogging up the roads? Good luck with your battle. More power to your elbow!'

'We are absolutely horrified at the suggestion of the movement of fill and surcharge material through Thorpe Bay'

'The thought of these heavy diesel lorries driving up and down Thorpe Hall Avenue, undoubtedly knocking branches of the trees as they go, is quite abhorrent. This is still one of the greener parts of the town, and should be preserved as such'

'Heavy duty lorries will create dust, dirt and mayhem as they trundle along our roads, to say nothing of the damage their weight will do to the already poor condition of the road surface particularly in Thorpe Hall Avenue'

'I am against this proposal in its present form. I have tonight driven down the A127 and I cannot see how the lorries will avoid bunching up almost ending up nose to tail. Also, the state of the running surface of Thorpe Hall Avenue is awful - what would all these additional lorries do to it!! The spoil if it must come, should come by barge (as happened to Wallasey Island) or by rail. This would help the environment that we are supposed to protect. Thanks again for all your efforts'

'Why not transport all this material by sea - to the Barge Pier? This enables larger quantities to arrive in batches, closer to site, and when the tide is out there would be a "rest" time to distribute material as needed. Flat bottom barges either side of the pier, vehicles ready to take it away"

'It appears developers plan to pump water out while they build. Where will it be pumped to? Apparently, it's OK to pump all this bad drainage out into the surrounding areas. Are they kidding? Surely, it's criminal to deliberately flood other people's property. Is our council saying it's OK to flood our public parks? These roads all have major sewerage drains only feet under the surface and it's well known how poorly these drains perform already. This sort of Over-Load would be forbidden on any privately run car-park simply because of the damage the excess weight would cause to underground systems'

'Why are all the other members of the planning committee voting in favour of this horrific unworkable plan? Is there something we don't know?'

'We thoroughly agree with all that you have said in your letter. From my point of view we should be working with nature here, not against it. An ideal place for a marina, I would say'

'What part of the phrase "Flood Plain" is not understood by the council. Surely it is obvious that to build on a flood plain is irresponsible and clearly ill advised. Would any councillors want their family living in property clearly at risk of flooding with all the risks and distress that would bring'

'The disruption to this whole area is totally unacceptable. The local roads will become hazardous with frequent large lorries trundling through the area day after day. Accidents will be much more likely and I would think more serious due to the volume and frequency of this unwanted and unnecessary traffic. There will also surely be significant damage to all the roads used for the transfer of this material. Totally unacceptable and appalling that councillors have voted for this to proceed - they should be ashamed of themselves. Their job is to look after the electorate and to protect them and the area in which they live'

'We are at a loss to understand why the council could even consider this. The speed, noise and amount of traffic is bad enough, it's become a 24/7 racetrack, cars backfiring, motor bikes with noisy exhausts.... without all the lorries and the pollution and damage to the area this proposal will bring. Obviously, anyone in favour of this doesn't live on the route – we appreciate housing is important but it seems excessive to proceed with all this entails for just 172 homes, surely there is a better way without impacting the environment'

'What chance would there be now of anyone on the route selling their house during this period - a few months would have been bad enough but two and half years!!??'

'I want to remind the Council that the CROSSRAIL project in London moved ALL the earth and infill from London Underground tunnels by SEA distributing it into the newly created Wetlands on the Rover Crouch. If this horrific idea is to go ahead, then the **Developers MUST FOOT THE BILL** and arrange transportation of land infill BY SEA to the existing Barge Pier. This pier is **NOT unsound**, although it is unsafe for swimmers to jump in owing to unknown depths of water. There are no visible indications of weakness in the structure. If the developers claim there is risk of structural unsoundness, then they should put it right!'

Pharmacists may provide additional support to NHS over strike

Pharmacists could be bought in to ease pressure on the NHS during strike periods, it has been reported. Chemists could be allowed to diagnose patients with minor conditions and prescribe antibiotics to try to reduce demand for GP appointments and cut backlogs.

Criticism of Christmas sales of e-scooters

Police have criticised the Christmas sale of e-scooters which are banned on UK roads as 'irresponsibly'. Privately owned e-scooters outside of a local authority hire scheme are currently banned.

Mid-life health checks go digital

Face-to-face GP appointments for mid-life health checks will end and be moved online under government plans to ease pressure on the NHS. Patients will instead be asked to complete a questionnaire, use a kit to take a blood sample at home and go to a pharmacy for a blood pressure check. A pilot scheme starts in Cornwall today (5th) with ministers hoping to introduce the approach nationwide.

Further train strikes announced

Extra rail strikes, including one on Christmas Eve have been scheduled over the

festive period. Staff at Network Rail are expected to walk out from 6pm on 24 December until 27 December.

Temperatures below freezing due

With overnight temperatures expected to fall to -6C (21F) in places this week the Met Office has issued warnings of severe cold weather. Frost and ice are expected and people are being urged to use their heating and to look out for people who are especially vulnerable.

Flexible working to be offered from day one

New government proposals mean employees will be given the right to ask for flexible working from their first day at a new job. The current laws says that workers have to wait for 26 weeks to seek flexible arrangements.

Parking charges increase

At least 16 local authorities across England have raised their car parking fees in the last two months or plan to do so, it is reported.

Antibiotics could be given to children at schools affected by Strep A

Antibiotics could be given to children at schools affected by Strep A to stop the spread of the infection, Schools Minister Nick Gibb has said. Mr Gibb said that the UK Health and Security Agency is "working closely with the schools involved and giving very specific advice to those schools which may involve the use of penicillin", after the ninth death of a child from the infection.

Ambulance staff to strike on 21 December

Ambulance staff across most of England and Wales will go on strike on 21 December in a dispute over pay. The coordinated walkout by the three main ambulance unions - Unison, GMB and Unite - will affect non-life threatening calls only, but it could mean people who have had trips and falls not being responded to.

'Fewer than a quarter' can comfortably afford Christmas and more are turning to credit

The proportion of those who say they can easily afford Christmas this year has nearly halved, according to a debt charity which is warning that more people are turning to credit. StepChange said fewer than a quarter (24 per cent) of people were in a comfortable financial position heading into the festive season, compared with nearly half (45 per cent) in 2021, which its report said reflected the surge in the cost of living this year.

Strep A antibiotics shortages

Some local pharmacies in England could see shortages of antibiotics used to treat Strep A infections, according to David Webb, England's chief pharmaceutical officer. Mr Webb said that while some pharmacies may struggle, there were "sufficient" stocks on a national level.
