# On Sunday 23 April 2023, there will be a national test of the UK Emergency Alerts service

Emergency Alerts is a UK government service that will warn you if there's a danger to life nearby.

In an emergency, your mobile phone or tablet will receive an alert with advice about how to stay safe.

The government does not need to know your phone number or location to send you an alert.

#### Reasons you might get an alert

You may get alerts about:

- severe flooding
- fires
- extreme weather

Emergency alerts will only be sent by:

- the emergency services
- government departments, agencies and public bodies that deal with emergencies

What happens when you get an emergency alert

Your mobile phone or tablet may:



- make a loud siren-like sound, even if it's set on silent
- vibrate
- read out the alert

The sound and vibration will last for about 10 seconds.

An alert will include a phone number or a link to the GOV.UK website for more information.

You'll get alerts based on your current location - not where you live or work. You do not need to turn on location services to receive alerts.

#### What you need to do

When you get an alert, stop what you're doing and follow the instructions in the alert.

If you're driving or riding when you get an alert

- You should not read or otherwise respond to an emergency alert whilst driving or riding a motorcycle.
- If you are driving, you should continue to drive and not respond to the noise or attempt to pick up the mobile phone and deal with the message.
- Find somewhere safe and legal to stop before reading the message. If there is nowhere safe or legal to stop close by, and nobody else is in the vehicle to read the alert, tune into live radio and wait for bulletins until you can find somewhere safe and legal to stop.

It is illegal to use a hand-held device while driving or riding.

#### If you cannot receive emergency alerts

If you do not have a compatible device, you'll still be informed about an emergency. The emergency services have other ways to warn you when there is a threat to life.

Emergency alerts will not replace local news, radio, television or social media.

#### If you're deaf, hard of hearing, blind or partially sighted

If you have a vision or hearing impairment, audio and vibration attention signals will let you know you have an emergency alert.

#### Alert languages

Emergency alerts will be sent in English. In Wales, they may also be sent in Welsh.

#### Stagnating wages 'cost UK workers £11,000 a year'

Figures from the Resolution Foundation show that 15 years of wage stagnation has left British workers £11,000 worse off per year. The think-tank also found typical UK household incomes have fallen further behind those in Germany. In 2008 the gap was over £500 a year, now it is £4,000.

#### Anti-social yobs to face swift justice

The Prime Minister is to launch a new "immediate justice" strategy next week which will see anyone who commits anti-social behaviour such as graffiti or fly-tipping forced to clean it up within two days. Rishi Sunak is also thought to be considering plans to dock benefits and allow local communities to decide how people are punished.

#### UK phones to get emergency alert with test in April

A siren-like alert is to be sent to mobile phone users in the UK next month to test a new government public warning system. It will allow government and emergency services to send urgent messages warning the public of life-threatening situations like flooding or wildfires. The test is expected to take place in the early evening of Sunday 23 April.

#### Shortfall in pothole repair budgets hits new high, research shows

Shortfalls in pothole repair budgets among local authorities have reached a record high, according to research. Councils in England and Wales said they only received two-thirds of what they needed during the current financial year to stop local roads further deteriorating, the Annual Local Authority Road Maintenance (ALARM) survey found, which resulted in a total carriageway maintenance budget shortfall of £1.3 billion.

# One in 24 local road bridges are unsuitable to carry the heaviest vehicles, says report

One in 24 road bridges in Britain are no longer suitable to withstand the weight of the heaviest vehicles, a new review of structures has highlighted. Local authorities identified 3,090 bridges as being 'substandard' at the end of last year, the RAC Foundation said, which means they are too weak to be used by 44-tonne lorries.

#### RMT union members at Network Rail vote to accept new pay offer

RMT union members at Network Rail have voted to accept a revised pay offer, ending a long-running dispute over jobs, pay and conditions. The new offer is for Network Rail staff, including signallers and track maintenance workers, but will not mean a total end to rail strikes because staff working for train companies are part of separate disputes.

#### 'Zombie' knife ban

The sale and possession of machetes and zombie-style knives are to be banned by ministers. It is reported that Policing minister Chris Philp is to rewrite weapons legislation to make it an offence to sell machetes or unmarked zombie-style knives, a



type of bladed weapon inspired by zombie films, online or in high street shops and to possess them in the home.

#### Interest rate rise

Interest rates have been raised to their highest in 14 years, with the Bank of England "much more hopeful" for the UK economy. Rates were lifted to 4.25 per cent from four per cent following the unexpected rise of inflation rate in February. The Bank said the UK was now no longer heading into an immediate recession.

#### Junior doctor strike

A four-day period of industrial action is set to take place from 11 to 15 April for junior doctors. Members of the British Medical Association (BMA) will strike after Health Secretary Steve Barclay said their pay claim is "unaffordable". The BMA said only a 35 per cent increase will be enough to make up for 15 years of below-inflation rises.

#### **Dental crisis**

Almost two thirds of children in England have enamel or tooth decay in parts of the country, according to data from the Office for Health Improvement and Disparities.
