## Emergency alert system test on Sunday 23 April

On Sunday 23 April at 3pm, the Cabinet Office will be testing their new emergency alerts system.

Your mobile phone or tablet may:

- make a loud siren-like sound, even if it's set on
- silent
- vibrate
- read out the alert

#### The full message will read:

"This is a test of Emergency Alerts, a new UK government service that will warn you if there's a life-threatening emergency nearby".

"In a real emergency, follow the instructions in the alert to keep yourself and others safe."

"Visit gov.uk/alerts for more information."

"This is a test. You do not need to take any action."

#### Shed security

If you are installing a new shed this spring put it somewhere where you and your neighbours can see it.

This will help to deter potential criminals from breaking in.

Also check your sheds and gates are secured with close shackle padlocks and pad bolts. Remember to replace them if they have start to rust over the winter.

#### Be fraud smart - Booking a holiday online?

Planning to book a holiday or maybe a short break away, remember to do your research. If something looks too good to be true it probably is.

Stay scam savvy by reading online reviews from reputable sources before making any bookings.

You can also confirm if an accommodation really exists by verifying the address through web searches and online maps.

## 2) National Corner

#### Royal Mail reaches pay agreement

Royal Mail and the Communication Workers Union have reached an "in principle" agreement over pay and employment terms. The union's executive will meet next week to consider the deal, which if accepted, will then be voted on by union members.

#### **Voter ID**

Next month's local elections will be the first time that voters in England will need to show ID at polling stations. People without a form of valid ID will need to apply for a voter authority certificate by 25 April and there have been 64,069 applications for certificates since the beginning of the year. The LGA said councils have hired extra staff to inform voters at polling stations of the new rules and warned they could be "overwhelmed" on polling day as they deal with "the biggest change to in-person voting in 150 years".

#### **Nurses' strikes could continue until Christmas**

Nurses could strike until Christmas, the leader of the Royal College of Nursing has said. General secretary Pat Cullen also said there were "no plans" to co-ordinate strikes with those by junior doctors.

#### Maths review launched

A review into ensuring pupils in England study maths up to the age of 18, without making an A-Level in the subject compulsory, is to be set up. The advisory group will consider what maths skills students need, and whether a new maths qualification is necessary.

#### Some 'nicotine-free' vapes high in addictive substances, tests reveal

Some high street vapes claiming to be nicotine-free in fact contain the same level of addictive substances as full-strength e-cigarettes, tests shows. Data by Inter Scientific – which offers analytical testing of products to check whether they are following regulations – examined dozens of vape brands sold in shops across England and Wales.

#### Patients turn to private GPs as hundreds of surgeries close down

Thousands of patients are turning to private GPs after finding it impossible to get an NHS appointment as hundreds of practices shut down. Independent healthcare companies have reported a surge in demand since the pandemic, after a survey of 2,000 adults found that 32 per cent went to private GPs in the past three years and 53 per cent said they would consider using one.

#### Forced meter installations to be banned for over-85s

The forcible installation of prepayment energy meters in homes of customers over the age of 85 in Britain will be banned under new rules from the regulator Ofgem.
