#### **Last Years Tree Planting**

We have been advised by the council that the Parks Team have experienced a number of problems with the planting programme this year. The BERA donated trees were scheduled to be planted before now, but unfortunately this did not take place. The Parks Team confirms that the contractor has now applied for a further permit to plant the trees next week.

#### Veolia meeting on Tuesday 20th June at the Civic Centre

One of the points that was raised at the meeting was that, after collection, green bins, paper bins and food waste bins were being left on pavements causing possible hazards for pram, wheelchair and mobility scooters as well as a hazard for the visually impaired.

Part of Veolia's reply was that bins are returned to where they were collected from.

In order to try to minimize this problem can we please ensure that ALL bins and sacks (whatever colour) are left on the edges of your property and not on grass verges or, for those roads that are planted, on top of the shrubs. Also a reminder that they should not be put out the night prior to collection.

#### **Southend-on-Sea to celebrate Armed Forces Day**

Southend-on-Sea will gather to celebrate Armed Forces Day this Saturday 24 June and pay tribute to service personnel past, present and future as the annual tradition of a parade through the City High Street and a short service return.

Organised by Southend-on-Sea City Council, the procession of serving Armed Forces personnel, veterans and cadets will start from underneath the railway bridge in the High Street at 10.30am, as they march to Victoria Circus.

At 10.45am the parade arrives at Victoria Circus for an open-air public service of thanksgiving followed by gunfire at 11.00am and 2 minutes silence. The Southend Band will play a short concert at the conclusion of the service.

#### Shoebury railway station ticket office petition handed to MP

Campaigners fighting to save Shoebury rail station's ticket office have handed over a 600-signature petition to an MP.

The East Beach Residents' Group launched the petition after learning the ticket office, run by c2c, was earmarked for closure. That would potentially leave the station with just one ticket machine, which is often out of order.

Their petition was presented to Sir James Duddridge, Conservative MP for Rochford and Southend East, who called for a meeting with the campaigners. The association hailed the meeting as "productive".



There are often long queues for the machines at the terminus on the c2c Shoebury to Fenchurch Street line when the ticket office is not open. The rail company has installed a ticket machine inside the station but it has said it is likely to only have the machines inside the building in future. It is unclear whether the outside machine will be removed altogether.

The station is one of thousands reportedly earmarked for closure. Striking rail workers have cited the closures as part of changes to their working conditions which have led to industrial action.

## 2) National Corner

#### Number of children hospitalised from vapes quadruples in a year

Children are being admitted to hospital after using vapes, suffering from breathlessness and suspected lung damage, NHS England's medical director has revealed. Professor Sir Stephen Powis has spoken about his concern at the effect of vaping among young people and the extra strain it places on the health service, revealing that NHS staff across the country have seen a near quadrupling in paediatric admissions to hospital due to the impact of e-cigarettes.

#### Teachers in England to strike for two days in July

Teachers in England will strike over pay again on two dates next month, the National Education Union has announced. National strikes are scheduled for 5 and 7 July, with schools likely to fully or partially close.

#### Utility giants must pass price savings onto consumers

The Treasury will urge regulators to make sure that any falls in the price of energy, water, broadband and mobile phone services are passed onto consumers, it has been reported. There are concerns that those who have signed long-term contracts with utility companies, meaning that if such agreements were entered into when prices were high, they will not automatically benefit from falls in costs.

#### RMT announces three days of rail strikes in July

A fresh round of rail strikes is expected to disrupt national networks during July. The RMT said train operators had failed to make a new pay offer and that members working for 14 rail companies would, as a result, go on strike on 20, 22 and 29 July.

## Banks summoned to meeting with Chancellor over mortgages after interest rate rise

Banks and building societies are to meet Chancellor Jeremy Hunt to discuss the upheaval in the mortgage market. The meeting is likely to focus on more flexible support for those struggling to make increased payments, reports suggest.
