#### Ready, Steady, Read - this summer with Southend Libraries

Bookworms of all ages are being encouraged to take part in the annual summer reading challenge through Southend libraries.

#### Day travelcards to London to be phased out in the near future

People will have to use contactless or their Oyster card on TfL services once travelcards are phased, the deputy mayor of London Transport has confirmed.

The paper tickets offer unlimited travel on all London Transport services, including Tube, DLR, buses, trams and the London Overground.

They will soon no longer be sold or accepted on Transport for London (TfL) services.

Last year, 12m day travelcards were sold, double the number in 2020, but down from 27m in 2018, BBC News reports.

Weekly and annual travelcards will still be issued but last year just 20,000 of the latter were sold, down from 185,000 in 2018.

#### What will people travelling to London have to do instead?

Paper day travelcards are often used by people travelling into London for a day trip or by London residents for use on the Tube and other services.

Once they are phased out these passengers will be expected to use contactless or Oyster cards at barriers to these services.

#### What reasons have been given for the end of day travelcards?

The Deputy Mayor of London for Transport has said the "TfL can no longer afford" to fund the £40m Travelcard Agreement.

In a letter sent to Transport Secretary he said "the current price paid to TfL for these tickets is well below the price paid for the same tickets sold within London".

A consultation document has set out the changes, which would see the end of paper travelcards altogether.

It is anticipated that, if TfL ceases to accept day travelcards, rail operators will also stop selling Zone 1-6 travelcards.

## Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (London Road – Queensway to High Street)

Southend-on-Sea City Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 45, 46, 46A, 51 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby give notice that it intends to make the following amendment order:



The effect of the Traffic Regulation Order (TRO) would be to amend the parking controls in London Road between Queensway Roundabout and the High Street within Southend-on-Sea City.

The changes for on-street parking will amend the following Order; The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021.

#### Cashless parking payment fraud warning

Consumer groups have warned that cashless parking payments could be open to fraud, with criminals leaving fake QR codes on parking meters for people to use. Action Fraud have said that drivers should be wary if a QR code takes them to a site that asks for personal information, login details or payment.

NHS consultants warn of further strikes unless government enters talks The British Medical Association (BMA) have warned of continued strike action from consultants unless the Government enters 'meaningful talks' with them. Vishal Sharma, chair of the British Medical Association's consultants committee, has warned of a 'two tier' system being created with consultants leaving the NHS due to pay concerns.

#### 38 million GP appointments delayed for a fortnight

More than 38 million appointments in England have been delayed longer than a fortnight according to NHS data. Between October 2022 and May this year, the most recent month for which figures are available, nearly 5 million patients waited more than a fortnight for a GP appointment every month.

#### **GPs consider strike action**

The British Medical Association (BMA) is preparing to ballot GP members over industrial action. According to a poll in Pulse magazine of GPs, more than half said



they would be willing to shut routine services for a day while a third said they would close services for a week.
