Fixed penalty notices issued for breaches of BBQ and Car Cruise PSPOs Southend-on-Sea City Council has successfully enforced its public spaces protection orders (PSPOs) this weekend after several breaches of the orders.

After another busy and fun-packed weekend in the City and along our award-winning beaches and seafront, pier and foreshore officers have unfortunately had to issue a fixed penalty notice (FPN) of £100 to a large group of people who flouted the BBQ ban PSPO, and community safety officers were forced to issue four £100 FPNs to drivers under the car cruise PSPO.

Leading up to the decision to issue the BBQ PSPO, there were some serious injuries sustained by children on Southend's beaches because people had not disposed of their barbeques safely and appropriately. Disposable barbeques are also extremely damaging to the environment.

The Car Cruse PSPO was brought in after many complaints were received from local businesses and residents regarding noise from vehicles, the smell of smoke in the air, loud music, parking breaches, littering and other examples of anti-social behaviour.



Beware of fake Microsoft 'spyware' pop-ups on your computer

Scammers are impersonating Microsoft in pop-ups warning your computer is infected with spyware.

These pop-ups appear suddenly on your screen. They claim that your device has a virus and that your personal and financial data is at risk, before asking you to call a phone number for support.

'Objects' found on the seabed delay removal of the masts of munitions ship SS Richard Montgomery sunk off the coast of Sheerness



Measures to lessen the threat posed by a sunken Second World War supply ship loaded with explosives have been postponed. The SS Richard Montgomery sank off the coast of Sheerness in August 1944 with 1400 tons of explosives aboard.

Even though the ship has been sitting in the water for more than 78 years, there is still considered to be a risk that the explosives could detonate, potentially causing a tidal wave that could wreak havoc on the town. Responsibility for the management of the wreck rests with the Department for Transport (DfT), which has been regularly monitoring the ship's condition. In recent years, signs of a deterioration in the ship's hull have been observed, which it is thought could increase the danger.

Two years ago it was decided that the ship's three masts – which project above the water line – would be removed, as it is thought that their weight is placing an additional strain on the deck-plating and so crucially on the cargo hold. A contract was awarded by the Government to safely remove the masts using jack-up rigs placed on the seabed, providing access to each mast via cranes.



The work was already delayed once after bombs were found lying on the seabed. They were removed last summer. But preparatory work which included a detailed survey of the wider area around the wreck has now identified another 18 "objects" on the seabed in locations which were required for the cranes.

The DfT has not revealed what the objects are. But in any case, the new information has meant the government department has had to re-assess the viability of using jack-up rigs. It has concluded it is not possible to proceed with this approach, because of the potential danger to those working on the project.

There is an exclusion zone around the immediate wreck site, marked by a ring of buoys, but increasingly yachts, jet-ski users and even paddle-boarders have been seen ignoring the exclusion zone and venturing dangerously close. They risk not only a large fine if caught, but also potentially losing their lives should the wreck chose that moment to blow up.



The SS Richard Montgomery is named after an American hero of their War of Independence against Britain. He died while attacking British Quebec in 1775.

Energy bills fall as new price cap comes into force

A change to the energy price cap has come into force, bringing down domestic gas and electricity bills, with a further, smaller fall expected this winter. A household in England, Wales and Scotland using a typical amount of energy will now pay £2,074 a year, a decrease of £426 a year.

Struggling parish churches 'to be rented out instead of sold'

The Church of England could rent out parish churches instead of selling them under plans to deal with falling congregations. Under the proposals being considered by the General Synod, the Church's legislative body, buildings would be allowed to lie "fallow" with the option to reopen them in the future. This could mean renting them out at times and offering them to other institutions, such as local authorities, under a shared ownership deal.

Headteachers ready to join strikes in autumn

Heads of schools are likely to join teachers in striking in the new academic year, according to the National Association of Head Teachers. The move is likely to lead to far more school closures on strike days in England from September.

Pylons to be forced on public to hit net zero goal

Hundreds of miles of overhead cables and pylons are expected to be fast-tracked through the planning system despite local opposition, so Britain can hit its net zero targets. The Department for Energy Security and Net Zero is reported to be devising sweeping planning reforms that industry leaders say are needed if the UK is to hit milestones such as eliminating fossil fuel generation by 2035.

Almost 13 million adults now struggling to pay bills, debt charity warns
New analysis by Debt Justice has found the number of UK households struggling
with heavy debt has increased by two thirds since 2017. The charity found about
12.8 million adults in the UK are falling behind on bills or finding repayments a heavy
burden.

More gambling clinics set up after record demand

NHS England is nearly doubling the number of clinics for gambling addiction after referrals reached a record high. Seven new clinics are to open this summer in addition to the eight already available around the country.

NHS strikes

The head of NHS England Amanda Prichard has warned that July's planned strikes in the health service could be the worst yet for patients. This month's consultant strike will bring a "different level of challenge" than previous strikes, she said.



Energy boss says prices might rise this winter

Energy prices could increase this winter forcing governments to step in and subsidise bills again. If the Chinese economy strengthens quickly and there is a harsh winter, gas prices could rise, putting pressure on consumers, the head of the International Energy Agency has said.

Train delays

Rail passengers are being warned of disruption due to an overtime ban by train drivers in the Aslef union. Many will reduce their service levels over the next few days and passengers are being advised to check before they travel.

Water firms discharged raw sewage 300,000 times last year, court hears Water companies discharged raw sewage into rivers and seas via their storm overflows more than 300,000 times last year, according to new data presented to the High Court. The vast majority of the releases were illegal, the court heard, which came as Thames Water was fined £3.34 million in a separate hearing for sewage dumping.

Over-50s who retired at start of pandemic much poorer

A report by the Institute for Fiscal Studies (IFS) has found that people over 50 who left work during the pandemic are "much poorer" in general than other retirees. The IFS said 48 per cent of those who retired in 2020-21 were now living in relative poverty.
