Council tax rise warning

There have been warnings that growing financial pressure on councils could lead to an increase in council tax. As councils look to set their budgets for next year, Chair of the LGA said: "Balancing the books is proving increasingly difficult for us and for all councils across the country."

Help for first time buyers

The Government will introduce a new package of support for first time buyers, it has been reported. Options include longer term fixed-term mortgages and a new version of the Help to Buy scheme.

'Bad management' not inflation to blame for councils going bankrupt

Councils across England are having to issue Section 114 notices because of poor financial management and not a lack of money, according to Chairman of the new Office for Local Government (Oflog). However, Cllr John Fuller, of the LGA's Resources Board, said growing demand pressures meant many more councils face having to make the same decision. He told MPs last month: "There is a general understanding that, if not this year, next year about half of local authorities will be in [financial] distress."
